

Thumbtack Press Framed Print Twitter Thumbtack Kickback Official Rules

Enter the Thumbtack Kickback for a chance to win a framed print valued at up to \$150 from Thumbtack Press, Inc. (“Thumbtack Press”).

Here’s what you have to do:

Read the monthly blog post at www.thumbtackpress.com/blog to find out what prints are being given away.

Follow @thumbtackpress on Twitter at <http://twitter.com/thumbtackpress>.

Click the link in the blog post or copy and paste to tweet the official Thumbtack Kickback message with included hashtag.

We’ll announce the winner on the @thumbtackpress Twitter page. If it’s you, make sure to send a direct message via Twitter within 48 hours including the name of the print you wish to receive. Remember, all entries must be received by 11:59 pm/cst on the Wednesday before the final Friday of the month. Limit one entry per month per person/twitter address.

(“Thumbtack Press” or “Sponsor”). Entrants must tweet the official contest entry message provided weekly at www.thumbtackpress.com/blog. Entries will be accepted from the time a blog post announces the contest until 11:59pm CST the Wednesday before the final Friday of the month.

ELIGIBILITY: The Thumbtack Press Framed Print Twitter Giveaway (the “Thumbtack Kickback”) is open only to legal residents of the fifty (50) United States (including the District of Columbia), who are 18 years of age or older at the time of entry. THUMBSTACK KICKBACK TIMING: The Thumbtack Kickback begins when a blog post announcing the contest at <http://www.thumbtackpress.com/blog> is published. The Thumbtack Kickback ends on the Wednesday before that month's final Friday, at 12:59 central standard time (the "Promotional Period").

HOW TO ENTER: To enter, visit www.thumbtackpress.com/blog and tweet the official giveaway message linked in the weekly Thumbtack Kickback blog post. Winner will be notified via the @thumbtackpress page. You will be required to contact Thumbtack Press by direct message via twitter within forty-eight (48) hours if you have been notified you are a winner. All entries must be received by 11:59 p.m. ET on the Wednesday before that month's final Friday. Limit one (1) entry per day/per person/twitter address. No person/twitter address can win more than one time for the duration of the Thumbtack Kickback. **NO PURCHASE NECESSARY.**
